**September 12, 2019, Munich** – The Supervisory Board of ARRI AG informs about a change in the Management Board of ARRI AG.

After five years as a member of the ARRI AG Management Board, Dr. Pohlman has decided to accept a new professional challenge as of November 1, 2019.
