Requirements

- a. Certificate of Insurance must be provided by Grantee with ARRI Inc. as loss payee at a \$1 million minimum coverage, certificate must state there is no unattended auto exclusion;
- b. Copy of valid Drivers License must be provided by Grantee;
- c. Grantee agrees to provide finished project to ARRI for possible inclusion on showreel or other marketing efforts;
- d. Grantee will also provide or allow ARRI to capture 5-10 production stills featuring the ARRI camera behind the scenes which shall be cleared for promotional use by ARRI in print, online and public presentations;

- e. Grantee will make best efforts to provide at least 30 seconds behind-the-scenes video from project which shall be cleared for promotional use by ARRI in online and public presentations;
- f. Grantee must include the Captured by ARRI logo in end credits and the following statement: "This project/title of project was made possible with support of the ARRI FRANZ WIESER Grant"
- g. Grantee must provide 1-2 quotes *each* from Director, DP and Producer about their experience working with the ARRI camera on the project;
- h. Grantee must provide 1-2 quotes from Director in regards to being awarded the ARRI grant;
- i. ARRI has the right to use the project's title and Grantee's name in press releases discussing ARRI Inc.'s support of the sponsored project. Release is subject to approval by Grantee;
- j. Any additional lenses, support, or equipment beyond this package must be rented or arranged by Grantee;
- k. Grantee will cover shipping costs unless package check-out is fulfilled from an ARRI location.
